

**ORDINANCE NO. 2024-03**

**AN ORDINANCE FOR THE  
LEVY AND ASSESSMENT OF TAXES FOR  
CORPORATE PURPOSES WITHIN THE  
NORTH SUBURBAN PUBLIC LIBRARY DISTRICT  
FOR THE  
FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025**

WHEREAS, on August 15, 2024 the Board of Trustees of the North Suburban Public Library District of Winnebago and Boone Counties, Illinois, adopted a Combined Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 2024 and ending June 30, 2025 and said Ordinance was published August 20, 2024 and is now in full force and effect; and

WHEREAS, careful and adequate consideration has been given in ascertaining and determining how much money must be raised by taxation for all corporate purposes for said Library District for the next ensuing year; and

WHEREAS the total amount of the appropriation legally made which is to be provided for from the corporate tax levy for such fiscal year is the sum of \$3,857,100 and from special tax levies is the sum of \$799,000 as shown in the Combined Budget and Appropriation Ordinance.

WHEREAS, said Budget and Appropriation Ordinance was adopted on August 15, 2024, and published on August 20, 2024, and, as published, is attached hereto as Exhibit A, and is incorporated herein by reference.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE NORTH SUBURBAN PUBLIC LIBRARY DISTRICT, WINNEBAGO AND BOONE COUNTIES, ILLINOIS, as follows:

Section 1. That the sum of \$3,857,100 must be raised by the general corporate tax levy for the next ensuing year, and that the sum of \$3,857,100 shall constitute the levy for general

corporate purposes of the North Suburban Library District on the equalized or assessed value of the taxable property of said Library District.

Section 2. That the sum of \$799,000 must be raised by special tax levies for the next ensuing year, and that the sum of \$799,000 shall constitute the special tax levies of the North Suburban Public Library District on the equalized or assessed value of the taxable property of said Library District as follows:

A.	Municipal Retirement Tax	\$242,200
B.	Tort Liability Insurance Tax	\$44,200
C.	Audit Expense Tax	\$10,000
D.	Equipping and Maintenance Expense Tax (.02%)	\$339,400
E.	Social Security Tax	\$143,200
F.	Risk Management Tax	<u>\$20,000</u>
	Total:	\$799,000

Section 3. That the foregoing taxes shall include all taxes levied by the North Suburban Public Library District, if any, for bond and interest requirements, by ordinances, certified copies of which have hereto before been filed in the office of the county Clerks of Winnebago and Boone Counties, Illinois.


Section 4. That said taxes so levied and assessed, as aforesaid, shall be collected and enforced in the same manner and by the same officer as the county taxes, and shall be paid over by the officer so collecting the same to the Treasurer of the said North Suburban Public Library District, as provided by law.

Section 5. That the Secretary of the said North Suburban Public Library District shall forthwith make and file with the county Clerks of Winnebago and Boone Counties, Illinois a certified copy of this Ordinance, and that the rate percent be ascertained, and the taxes aforesaid extended as provided by law upon the full, fair cash value as equalized or assessed by the


Department of Revenue on all the taxable property within said North Suburban Public Library District, as provided by law.

Section 6. This Ordinance shall be effective upon its passage and approval by the Board of Trustees of the North Suburban Public Library District.

The above Ordinance is passed and approved by the Board of Trustees at a duly convened meeting held on October 17, 2024.






